## Pricing Guidelines

\$150.00 for 2 hours with up to 60 guests, including swimmers and spectators, shall be paid with the application.

\$75.00 deposit is required. If no damage is present and the facility is left clean, the deposit will be applied to rental fee. Otherwise, deposit will be forfeited and full rental fee will be due.

### Lifeguards Required:

Lifeguards will be provided for each group. There will be a \$20.00 additional fee for each additional 25 guests. The Durant City Pool management will determine the number of lifeguards required. A final count is requested 48 hours prior to the scheduled event.

## Posted Rules

- Adequate adult supervision is required. The Applicant must provide the following supervision: One (1) adult per five (5) children under the age of eight (8), One (1) adult per ten (10) children over the age of eight (8).
- Bathing suits are required (all suits must have a liner). No shorts or cut-offs. Only solid white t-shirts are allowed in the water.
- Everyone must shower before entering the pool.
- NO SMOKING OR USE OF TOBACCO
- NO ALCOHOLIC BEVERAGES
- All food must be kept in the food court area.
- No silly string, confetti or anything that will stain when wet.
- Patrons with open sores or any infectious disease are not permitted in the pool area.
- NO RUNNING (Time out enforced for breaking rules).
- Profanity, improper behavior, fighting or vulgar language will not be tolerated.
- No display of affection at any time will be allowed (this is a family environment).
- Only "Coast Guard Approved" lifejackets are permitted. Life jackets are permitted only in the shallow area of the pool. Arm floats, water wings, personal rafts and floats are not permitted.
- Only one (1) person on the diving board at a time and only one (1) bounce.
- Only one (1) person up the ladder of the slide at a time.
- You must be 48" tall or pass a swim test to go down the slide.
- The pool may be cleared for a minimum of 30 minutes in the event of lightning or thunder.

**Inclement Weather Provision**

A rental will be considered complete once 50 minutes of the rental has been completed without inclement weather or other uncontrollable circumstances.

If conditions deteriorate before 50 minutes has passed, a make-up date can be established for the remaining time, if a date is available.

**Agreement**

The applicant shall be held responsible for complying with the terms of this agreement as to oversee participant behavior. Abuse shall be just cause for dismissal from the facility or refusal of future use. *Applicant also agrees to be responsible for the cleanliness of the facility at the conclusion of the party.*

All individuals and organizations agree to save and hold the City of Durant harmless from any and all loss, claim for loss, injury, liability or claim of liability arising out of an individuals or organizations use of the rented facility: whether such act giving rise to such claim is by omission or commission. In the event the City of Durant is adjudged liable or find it necessary to settle any claims arising out of an individual or organizations use of the facility, the individual or organization agrees to indemnify the City of Durant for all costs.

It is understood and agreed that the Durant City Pool has the right to change time and/or date if it is deemed necessary due to inclement weather or mechanical problems at the pool.

By my signature below, I agree to pay for additional guards as determined, at the above rate, to end the party by the specified time, to follow the posted rules and to leave the facility clean and undamaged. Upon inspection of the pool and premises by pool management, applicants deposit will be refunded accordingly. I understand that I may incur additional charges if I breach this agreement.

Any cancellations must be made not less than five (5) days before the reserved date or deposit and fees will be forfeited.
